



Participation Terms and Conditions

By choosing "I Agree" below, you are agreeing to the following terms and conditions:

Liability Waiver and Release - For Minors

I have chosen to have my child, or a child in my legal care, or myself participate in instruction provided by Showtime Theatre Company. I acknowledge that I understand the nature of the activities my child will be participating in and the possibility that despite precautions, accidents and/or physical injury may occur.

I/we agree to release and hold harmless Showtime Theatre Company and their participating partners, including its teachers and staff members, from any cause of action, claims, or demands now and in the future. I/we will not hold Showtime Theatre Company liable for any personal injury or any personal property damage or loss, which may occur on the premises before, during or after classes, rehearsals, performance or other activity which may occur at a Showtime Theatre Company sponsored event.

Furthermore I/we agree to read and follow Showtime Theatre Company policies and take full responsibility for my/our behavior in addition to any damage I/we may cause to the facilities utilized by Showtime Theatre Company.

I authorize and agree that Showtime Theatre Company may take and use photographs, videos or likenesses of myself or my child as needed for its record keeping, advertising, social media and/or public relations projects and that I have no rights to the same and will not be compensated for the same.

Tuition:

- Workshop series tuitions must be paid for in full prior to the first class.
- Ongoing classes, must be paid monthly, prior to the first class of the month.
- Main Stage show tuitions can be paid in installments as described on the website per production.
- I understand that participation will not be allowed without completion of the payment requirements.



Student Class Expectations:

- Students/Participants are expected to listen to all instructions given by the director, music director, stage manager, choreographer, and/or student directors.
- Students/Participants will show respectful behavior at all times.
- Students/Participants will be prepared at all rehearsals with all rehearsal supplies, proper shoes and attire. (Students who are not wearing proper shoes (dance shoes or closed toed sneakers) may be asked to leave the class.)
- Students/Participants will treat the rehearsal and performance spaces with respect. (Eating and drinking should only take place in designated areas. No food or drink is permitted in the dance studio.)
- Students/Participants who do not adhere to the conditions above will be asked to leave the class. No refund for behavioral dismissals.
- For Main Stage Productions: All rehearsal conflicts must be approved by the Director ahead of time. Students can be removed from a production for unapproved absences.
- Please note: No refund will be granted for dismissal for excessive absences or behavioral issues.

Medical Release:

In the event of illness and/or injury for the above named student/participant, I authorize the faculty instructor, school personnel, Academy Director, or any staff of Showtime Theatre Company to consent to emergency medical treatment of the above named student and to execute any documents in my name, place and stead, to accomplish this purpose.

The administrators of Showtime Theatre Company shall make all reasonable efforts to inform the emergency contact person named in the registration form, to report an illness or injury, and obtain information relative to the care and treatment of the above named student.

I release my right to hold accountable Showtime Theatre Company and the personnel for any accidental occurrence.
